## JOB DESCRIPTION

Tobacco Factory Theatres is seeking an Assistant Director to support **Anna Girvan** direct her production of **Our Country's Good** in our Factory Company Season 2019. The production will be rehearsed in Bristol and performed in our Factory Theatre, in the round.

The Assistant Director will need to be available for:

Research from Mon 04 February 2019 Rehearsals from Tue 05 March 2019 - Tue 09 April 2019 Technical from Wed 10 April 2019 to Tue 16 April 2019 First preview on Wed 17 April 2019 Press Night at Tobacco Factory Theatres on Tue 23 April 2019 Directors' Lab and Post Show Talk on Fri 26 April 2019 End of run at Tobacco Factory Theatres on Sat 11 May 2019

## As Assistant Director, duties would include:

- Performing research tasks prior to rehearsals, including reading texts around the subject of the play and producing a small research pack on themes and issues within the play.
- Helping with finding experts to come into the rehearsal room to speak to actors on themes in the play.
- During rehearsals, collating research and noting down discoveries in the text.
- Attending production and other meetings, including preparation meetings (if available).
- Running lines with actors, running warm ups, communicating with stage management and the Senior Producer and Production Manager at Tobacco Factory Theatres about scheduling, keeping a note of progress in rehearsals.
- Being a supportive, sensitive and compassionate individual in the rehearsal room who is easy to approach, has great time management and a good sense of fun.
- Assisting the company in documenting the rehearsal process for the purposes of marketing, archiving and evaluating the project through blogs, social media and other forms, as agreed.
- Observing and assisting the Director in the production weeks as required.
- Making notes during previews to share with the Director. Once the show has opened, checking up on the show and noting where necessary.
- Attending and participating in post-show discussions by mutual agreement with the Senior Producer.
- Supporting the company whilst the play is in performance as agreed with the Director and Stage Manager, including attending and noting the production.
- Any further duties as required by the Director.
